The Greene County Legislative Body met at the Greene County Courthouse on Monday, April 19, 2021 beginning at 6:00 p.m. The meeting was available for a limited number of in person attendees (50 or less total) with alive Facebook feed broadcast through WGRV and also via ZOOM virtual meeting application for those that could not attend.

Mayor Morrison called the meeting to order to transact business that has lawfully come before the Honorable Body. Commissioner Brad Peters gave the innovation. Commissioner Lloyd "Hoot" Bowers led the Pledge to the Flag.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated they were present. Greene County Clerk Lori Bryant recorded and checked off each Commissioner present and those who were absent.

Commissioners Arrowood, Bible, Bowers, Bryant, Carpenter, Cobble, Crawford, Dabbs, Kesterson, Lane, Lawing, Parton, Peters, Powell, Quillen, Shelton, Tucker, Waddle, and White were present. Commissioner Burkey was absent. There were 20 Commissioners present and 1 Commissioner absent.

Mayor Morrison announced the Proclamation honoring Tommy Gregg, Former Mayor of the Town of Mosheim for his immeasurable contributions, exceptional leadership, and extraordinary record of public service accomplishment to the Town of Mosheim and Greene County.

Whereas, we are greatly honored to acknowledge and proclaim the immeasurable contributions, leadership, and extraordinary record of public service accomplishment of Tommy Gregg to the Town of Mosheim and all of Greene County; and

Whereas, we recognize Tommy Gregg as a favored native son born in Greene County June 16, 1946 to Thomas and Carrie Gregg also of Greene County. Tommy grew up in Midway and Mosheim, attending school at Midway and Mosheim, and graduating from Mosheim School in 1964; and

Whereas, Tommy established his love and loyalty of home as a young man; he began his lifelong journey of service to his community and country by joining the US Navy and serving honorably during the Vietnam War on active and reserve duty for 8 years, attaining the rank of Bosun's Mate 2nd Class. Returning home to Mosheim after the Navy, he went to work at nearby Berkline Industries to provide for his family; and

Whereas, Tommy Gregg has been an exceptional family man having been married to his wife Trudy Burchett for 54 years with whom he has a son, Michael and their daughter in law, Jen. Tommy is a true Christian example and fine servant of God, faithfully attending and serving in his church, Big Springs of Mosheim; and

Whereas, Tommy Gregg has never been a stranger to work and has always possessed an entrepreneurial, service-minded spirit; Tommy owned and managed the Midway Service Station. He went on to manage and operate the Blue springs Market in Mosheim for several years, and then Kwik Fuel at Exit 23, before becoming the manager of Atchley Drug center for a few years before his retirement; and


Whereas, Tommy Gregg is, and has been a very active contributor and leader to a distinguished list of organizations promoting and building Mosheim and Greene County including: the Mosheim Ruritan Club, the Volunteer State Car Club, the Town of Mosheim Planning Commission, the Greene County Industrial Development Board, the Executive Board for the First Tennessee Development District, the Greene County Partnership Board, and the First Tennessee Human Resource Agency just to name a few; and

Whereas, Tommy Gregg served 20 years as an Alderman on the Town of Mosheim Board, 1 year as Vice Mayor in 2012 before becoming the Mayor of the Town of Mosheim in 2013, a role in which he served with great accomplishment, honor, and distinction until his retirement in the spring of 2021. PUBLIC HEARING

David McLain, Director of Greene County Board of Education, spoke to the Commission in regards to the programs offered at the T. Howard McNeese Educational Center, which has been moved to the former Glenwood Elementary School, which is now Glenwood Educational Center. David McLain explained that the only program they kept was the Bridges Program, which is Bridges to Success. He said they would be bringing 5 programs to the Glenwood Education Center, which will include carpentry (CTE), masonry, and partner with TCAP.

Mayor Morrison announced the following in attendance in person and via ZOOM: County Attorney Roger Woolsey, Erin Elmore, Kevin Swatsell, Roger Willett, Danny Lowery, Wesley Holt, David McLain, David Beverly, Lori Bryant, Janie Fincher, Crystal Jessee, Ken Little, Reid Seals, Chris Shepherd, Dan Armstrong, Fred Sams, Mel Seaton, Charles Morelock, Matthew Elmore, and Jim Green.

Commissioner Bowers spoke to the Commissioners with concerns from Greene County Citizens who are receiving monthly increases on their Comcast bills and having channels removed when they are not authorizing them to be removed. Commissioner Bowers asked Commissioners Peters if he had checked on the Urban Growth Boundary issue that Judy Sexton had addressed last month in the public hearing. Commissioner Peters explained that he had spoken to the members from the Town of Greeneville in regard to this matter. The Comcast issue and broadband internet access were also discussed by the Commissioners and County Mayor during the meeting.

Mayor Morrison announced that the tango tango application for the Greene County Constables was up and running, along with the digital radios for the SRO Officers, the Sheriff's Auxiliary Core, EMS, and the EMA.

The Greene County Emergency Communications District (E911), Board of Directors met on Tuesday, February 9, 2021, at 3:30pm, at the Greene County Courthouse Annex, Conference Room, Chairman Tim Ward called the meeting to order. A rollcall of Board Members was called, with eight present, one absent, John Waddle joined by Zoom.

The prior minutes were presented to the Board for approval. Upon motion by Hoot Bowers and seconded by Jeff Wilburn, a roll call vote was made, the minutes were approved.

The Treasurer's Report was presented to the Board for approval. Upon motion by Hoot Bowers and a second by Robin Quillen, a roll call vote was made, the Treasurers Report was approved.

Director Jerry Bird gave a Central Dispatch Update. Central Dispatch is moving along well, they are still having Covid-19 issues, still moving towards a March 1 full central dispatch. All dispatch positions have been filled.

Seth Spradlin, the NCIC Coordinator told the board all the new hires are now NCIC certified and that as of Thursday this week, Central Dispatch would be doing NCIC countywide.

Director Jerry Bird gave a CAD update. All the equipment is ordered and they are having meetings every other week with the vendor, putting the system together, doing the data conversion. Hope to have in use in the next 4-6 weeks.



The Greene County Commission Education Committee met at 3:30 PM at the Greene County Schools Central Office for its regular January. Mask wearing and social distance were in effect.

Committee Members in Attendance: Lloyd Bowers, Bill Dabbs, and Paul Burkey. Tim White was absent. Director David McLain was present as well.

Others in Attendance: Mr. McLain also introduced the new School Finance Director, Kayla Crawford.

The Committee reviewed the minutes from the 1 February meeting. Mr. Bowers made the motion to accept the minutes. Mr. Burkey seconded. The motion to approve passed 3-0.

Mr. McLain presented a proposed County budget resolution to align \$482,704, including \$252,500 in newly approved BEP funding from the state and contributions from other sources, to various budget lines for execution. The BEP funding is Greene County Schools' share of the 2% BEP increase passed by the special session of the Legislature earlier this year. The School Board intends to distribute those funds to each of the 550 teachers in the system as a stipend that will amount to approximately \$475 for each teacher. Mr. Bowers made the motion to recommend approval. Mr. Burkey seconded. The motion passed 3-0.

Mr. McLain presented a proposed County budget resolution to re-align \$1,400,000 from the General Purpose Budget's unassigned fund balance to the Building Improvements budget line in order to fund numerous repairs, materials, and upgrades throughout system facilities (see attached list). Approval would leave approximately \$2.5M in the unassigned fund balance. This resolution would authorize putting out bids for these goods and services. Mr. Burkey made the motion to recommend approval. Mr. Bowers seconded. The motion passed 3-0.

Mr. McLain presented a proposed County budget resolution to re-align \$186,000 from the School System's Restricted Non-Instructional budget line to the Food Service Budget Food Service Equipment budget line for the purchase of Freezer/Coolers at Doak Elementary, cafeteria tables at South Greene, and a kitchen re-model at West Greene Middle School. This resolution would authorize putting out bids for these goods and services. Mr. Burkey made the motion to recommend approval. Mr. Bowers seconded. The motion passed 3-0.



The Chairman conducted a roll call vote, which carried 6-1, with Edwin Remine voting "No".

Other Business.

Water Signature Block for plats. The Planning Commission was informed that the wording of the existing signature block regarding water service that was required to be placed on plats prior to approval was not adequate to address concerns of water service providers. Staff submitted proposed changes to the water signature block, to be discussed at the March meeting.






